1. ORGANISATION

The organising authority will be the Brisbane Sailing Squadron on behalf of the Queensland Laser Association Inc..

2. RULES

The regatta will be governed by:

- the rules as defined in *The Racing Rules of Sailing*
- the Special Regulations of Australian Sailing Inc. (AS) Addendum A - Part 2;
- the rules and by-laws of the International Laser Class Association (ILCA) and the Queensland Laser Association Inc. (QLA);
- this Notice of Race and the Sailing Instructions.

3. ELIGIBILITY

- 3.1 Each competitor shall be a financial member of a District of the ILCA and a yacht or sailing club affiliated with a State or National Authority.
- 3.2 Age divisions for Masters shall be determined by the competitor's age as at 11th November 2018 and in accordance with the current ILCA Handbook.

3.3 To be eligible for Junior and Youth categories, a skipper shall not turn the age shown in the table below in the year in which the Championship is being contested.

3.4 A minimum of 5 entries shall be required to constitute a Division.

6. MEASUREMENT AND SAFETY

Random checks of yachts and equipment may be carried out at any time during the regatta. Failure to comply may result in disqualification from all races sailed prior to such inspection.

7. COURSES

Races will be conducted on the Brisbane River. The courses to be sailed will be detailed at the Competitors Meeting on the day of competition.

8. SAILING INSTRUCTIONS

Sailing Instructions will be provided at the Competitors Meeting.

9. SCORING

- The Low Point System will apply.
- Three races are scheduled, of which two shall be completed to constitute a series.
- When only one or two races have been completed, a boat's series score shall be the total of her race scores.
- Division results will be determined from the overall position in each fleet.

10. TROPHIES

Trophies and Prizes will be presented as soon as practical after the last race. The number of prizes in any division shall be dependent on the number of entries.

11. SAFETY

Personal flotation devices shall be worn at all times whilst afloat. Such devices shall be in good condition and in accordance with the specifications issued or approved by a national authority or standards organisation and branded in the country of origin or manufacture. Attention is drawn to RRS Fundamental Rule 1.2.

The Queensland Laser Association Inc., Brisbane Sailing Squadron their members, officers, officials and committees and all others involved in the management and conduct of this regatta, shall not be liable for any loss of life or property, personal injury or damage caused by or arising from participation in this event. All entrants shall have a current Third Party Insurance Policy with a racing cover considered by their insurer as adequate for the risks involved. (Minimum AUD\$5 million, recommended AUD\$10 million).
